LOUISVILLE, Ky.—(ANP) — The City of Louisville has denied that racial segregation in city parks is unconstitutional, in a brief filed in Federal Court here. The brief is in answer to a suit to open all parks to Negroes.

Earlier, Judge Roy M. Shelbourne had turned down a motion by the city to dismiss the suit, which was filed in behalf of 11 Negro children last May, No hearing date has been set.

The city says there is no ordinance pertaining to the separate use of parks by Negroes and whites, and says there is no state law requiring segregation.

In an editorial under the tible. "About Till's Father," on the front page, the Jackson Daily News wrote in part:

The Daily News finds—itself in complete agreement with a statement. by NAACP atterney William Huff, who said that the circumstances surrounding the death of Emmett Louis Till's father have no bearing on the case minding. The Daily News shares the belief . . that NAACP embellishments of the true facts in the case were out of place.

"... NAACP distortion was just one of many, deliberate lies told about the case. It brought much sympathy for Till's mother and for the NAACP cause. No one checked the facts until the Daily News became interested."

"The Daily News would like to find itself in agreement with Neuro organizations oftener but before it can do so, the Negro organizations will have to hold the truth in higher regard . . Let the truth speak for itself. All Mississippians are willing to stand on the facts, if they find a publication outside the South willing to fell them."
